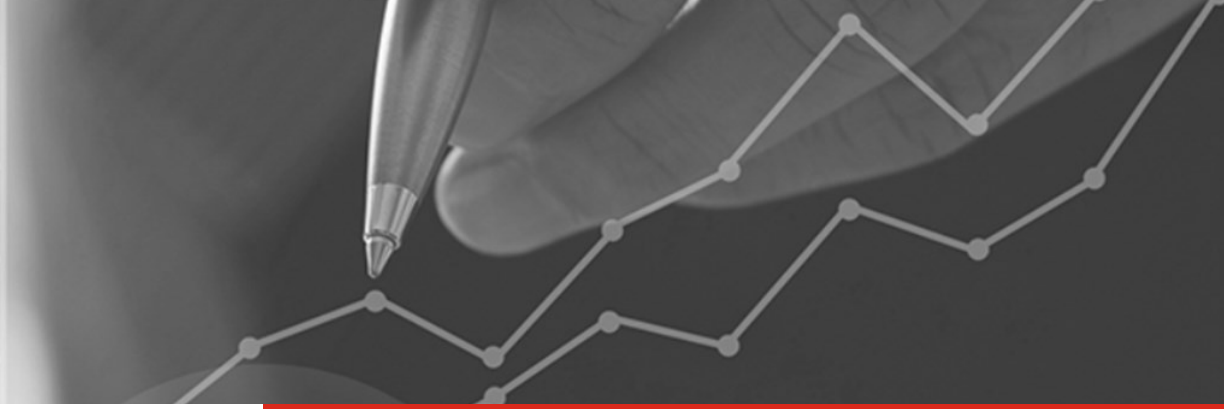

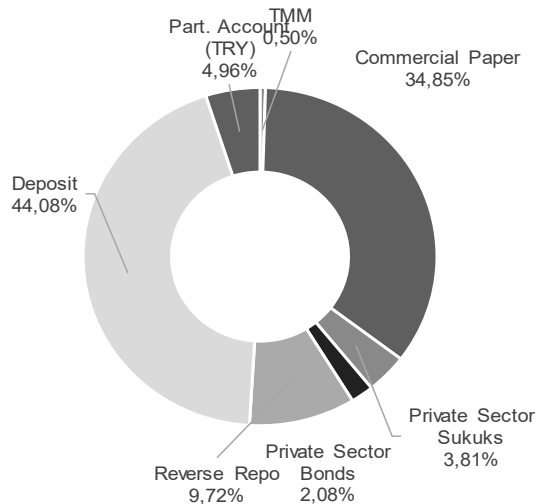
Asset Allocation

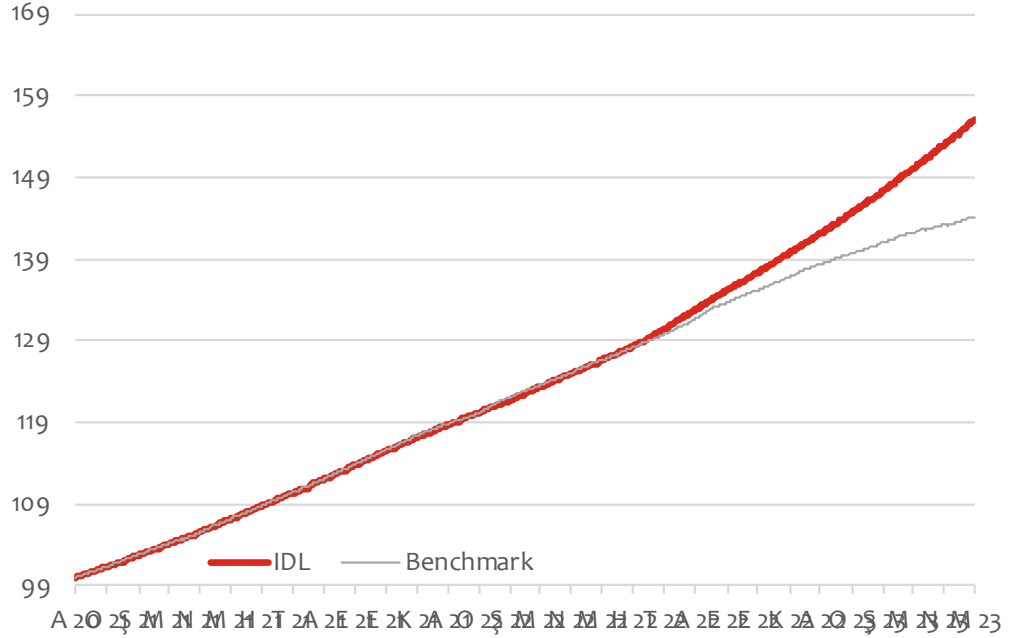
