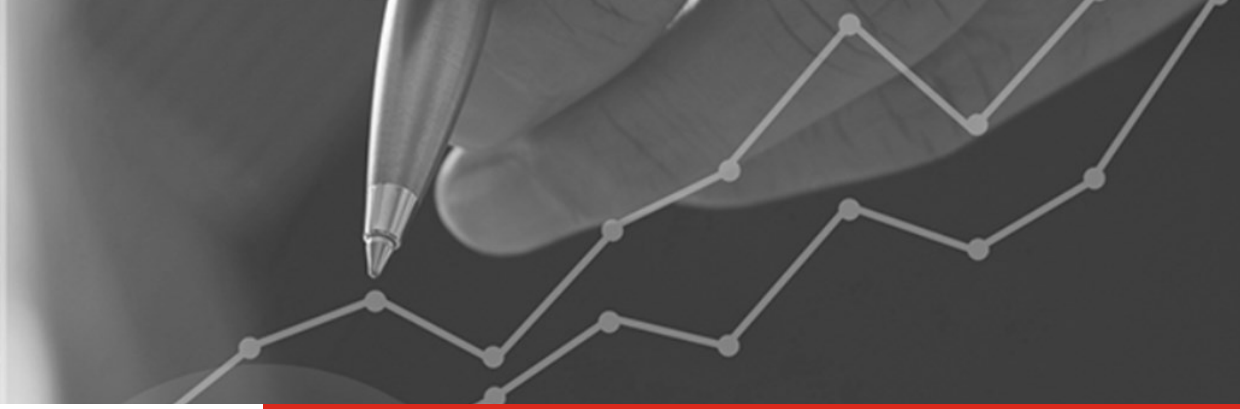

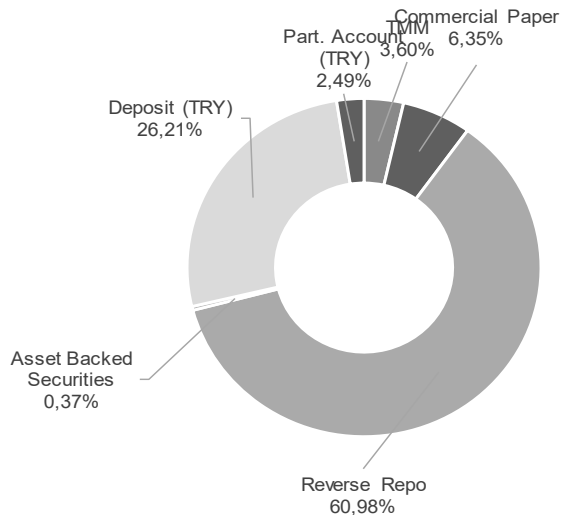
Asset Allocation

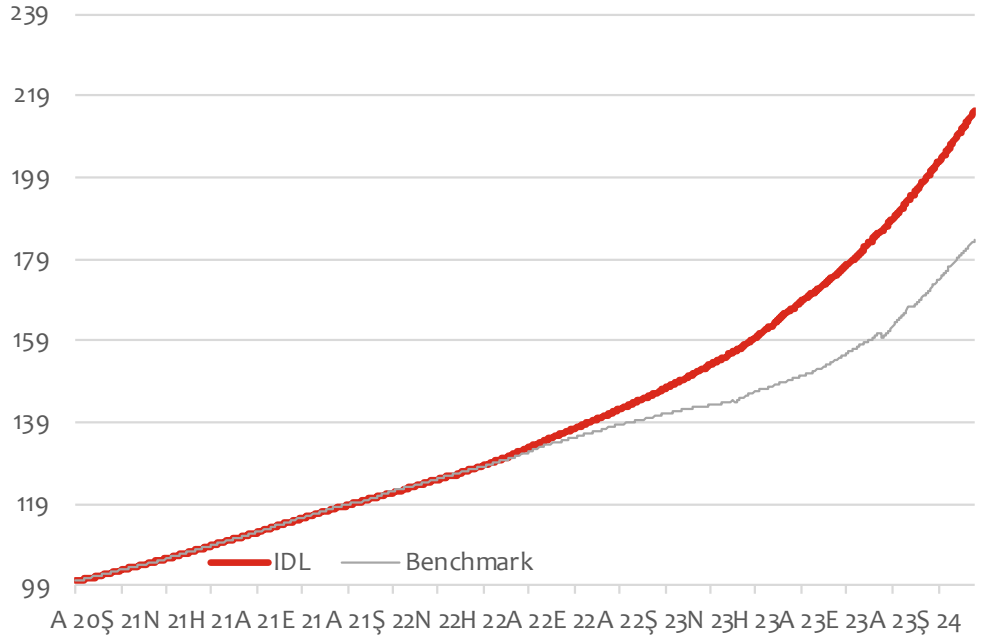
