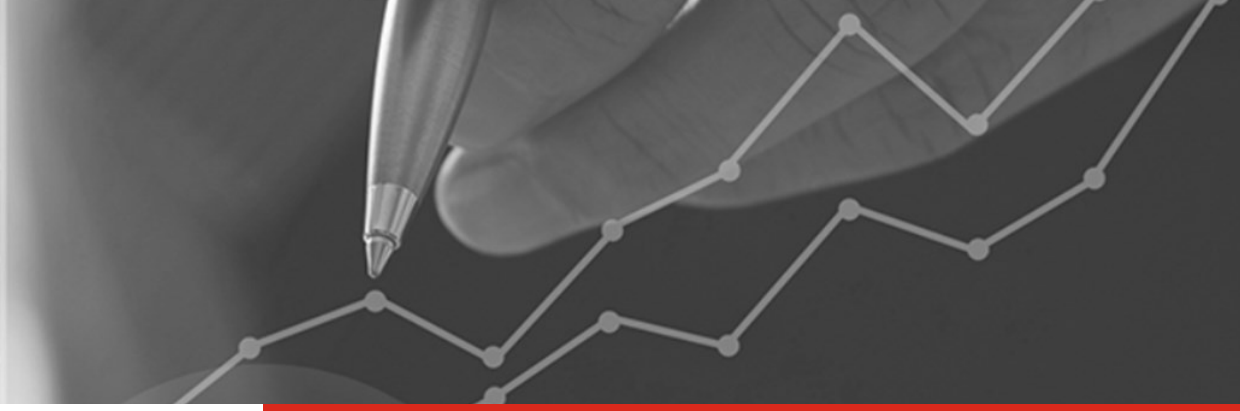

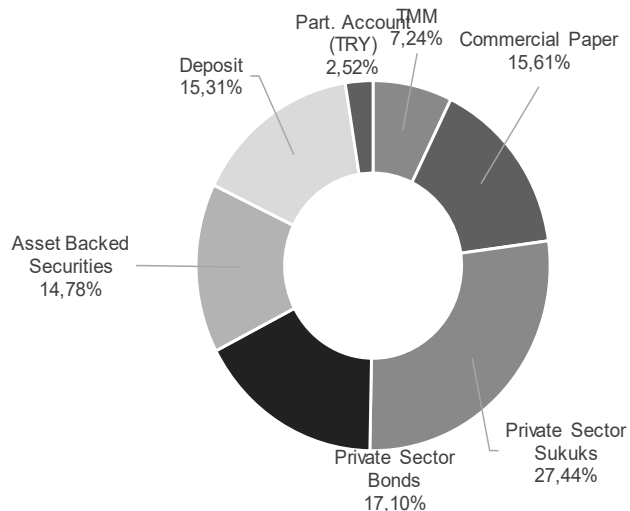
Asset Allocation

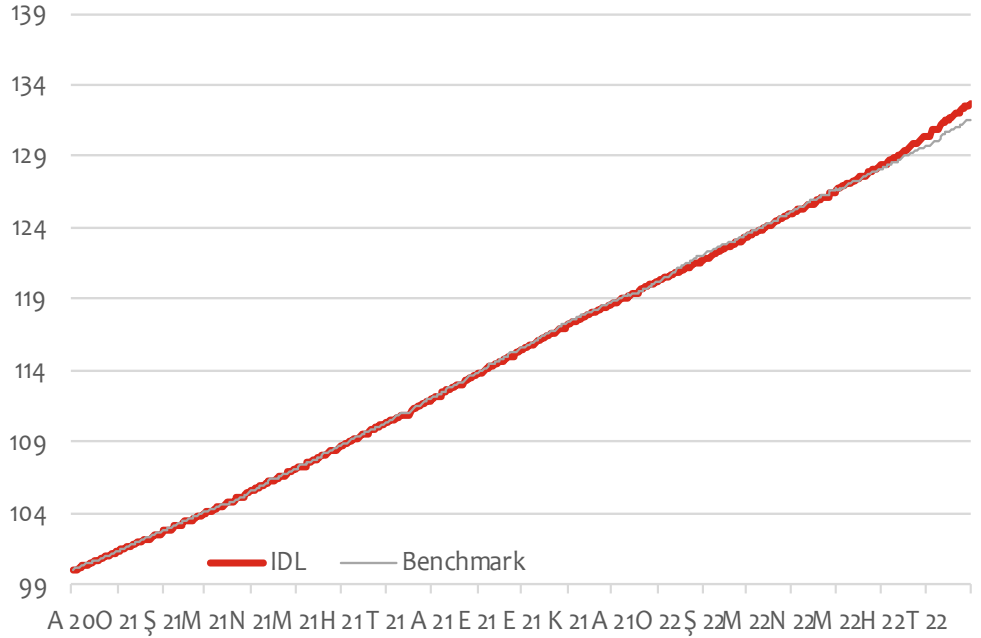
