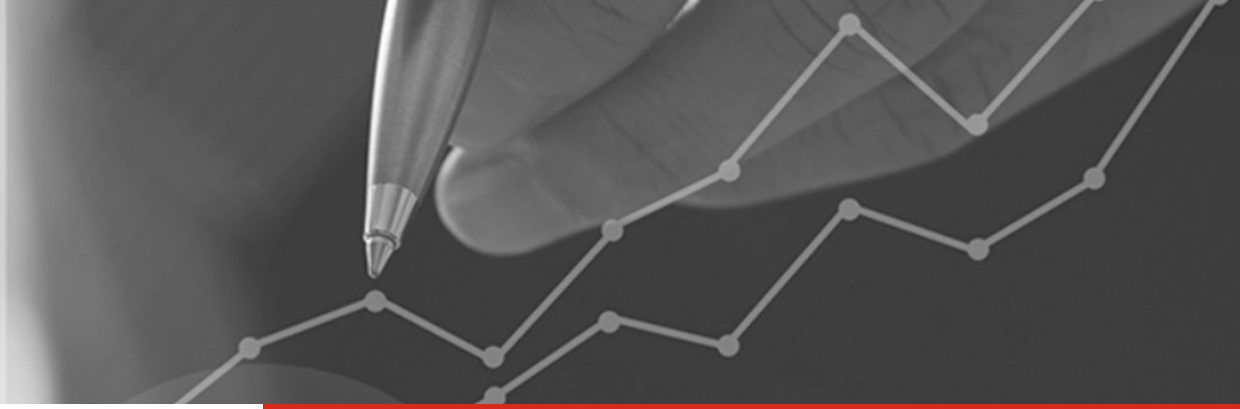

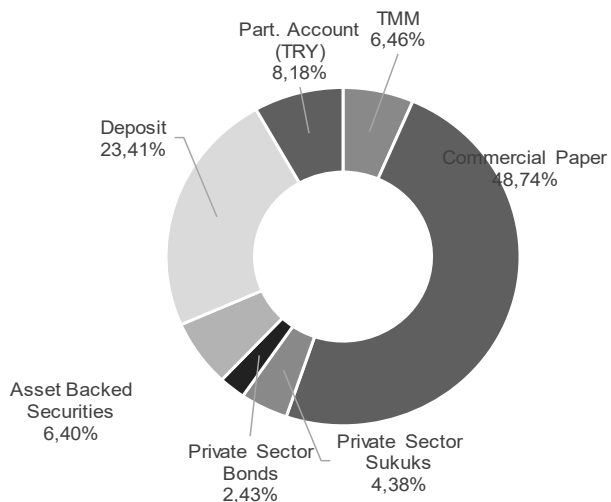
Asset Allocation

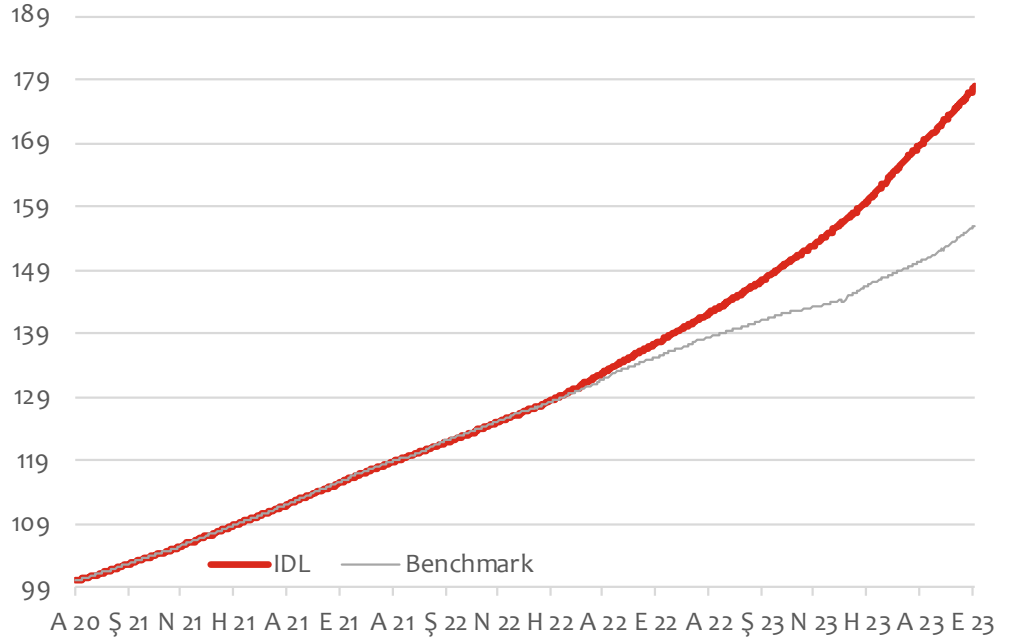
