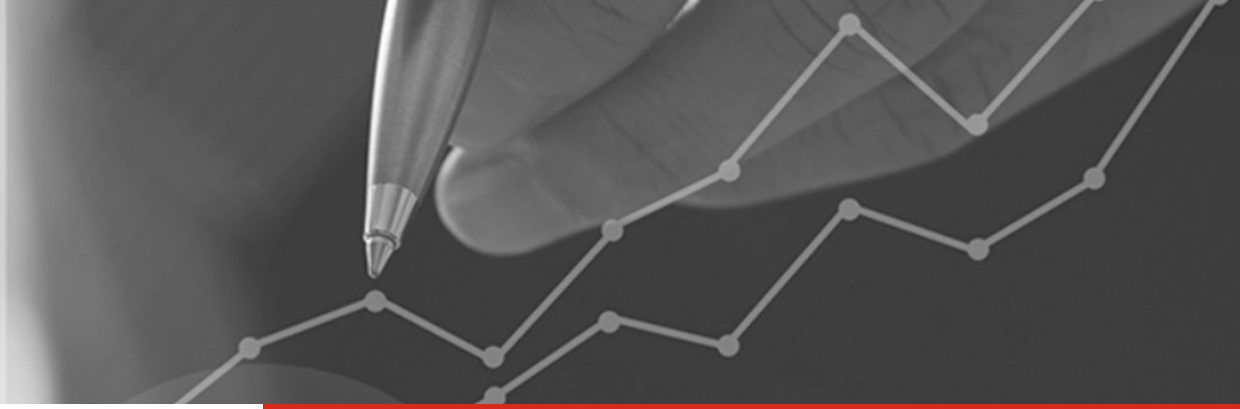

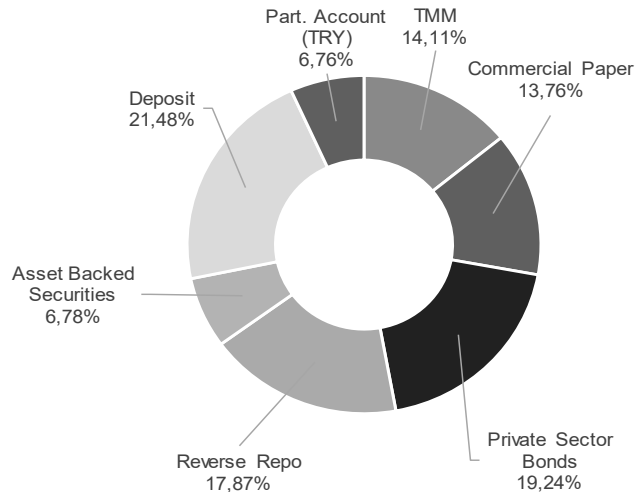
Asset Allocation

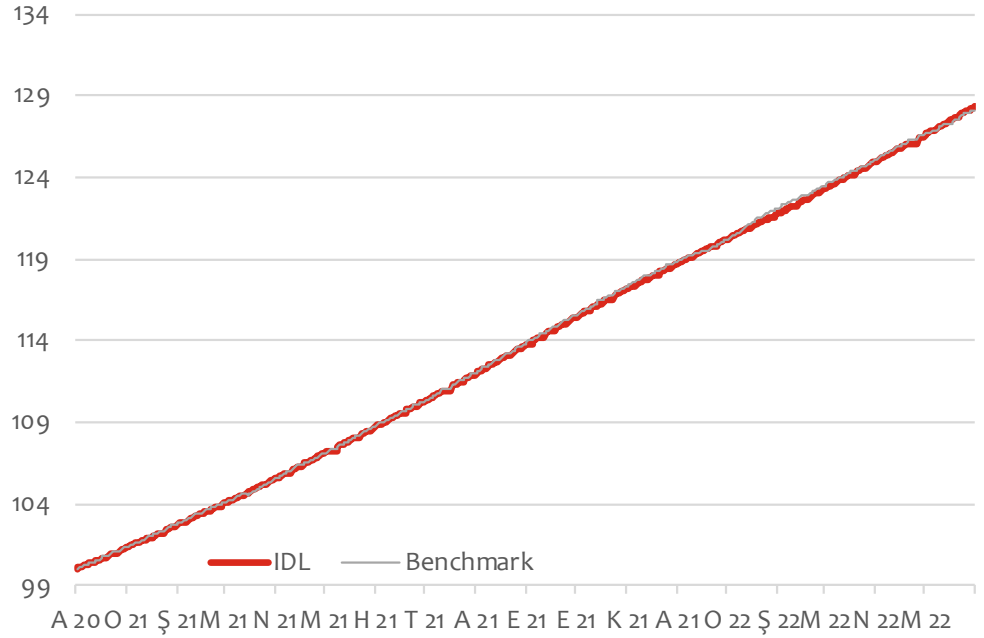
