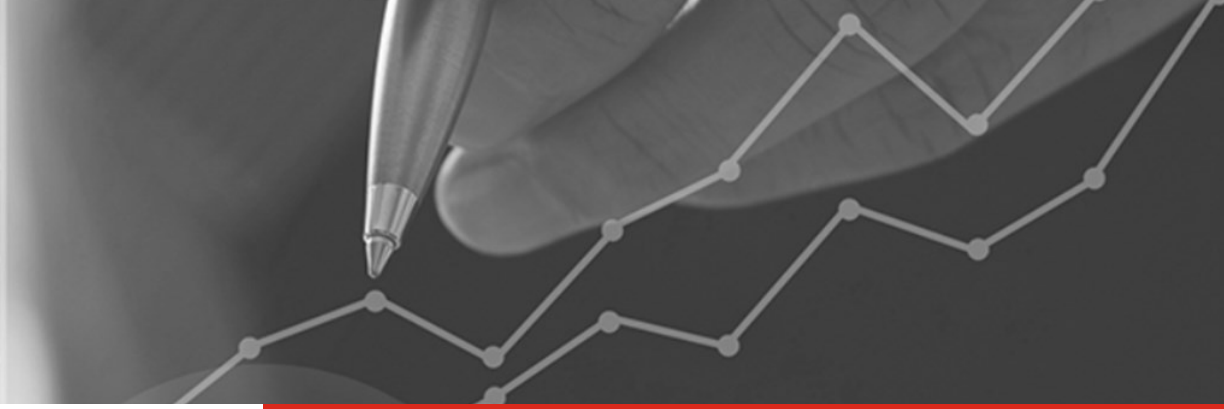

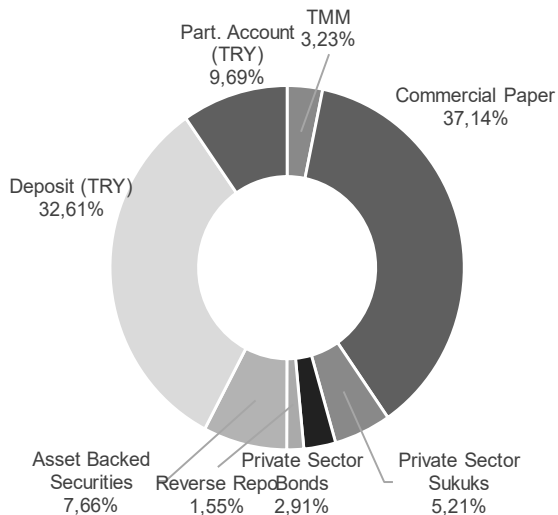
**Asset Allocation**

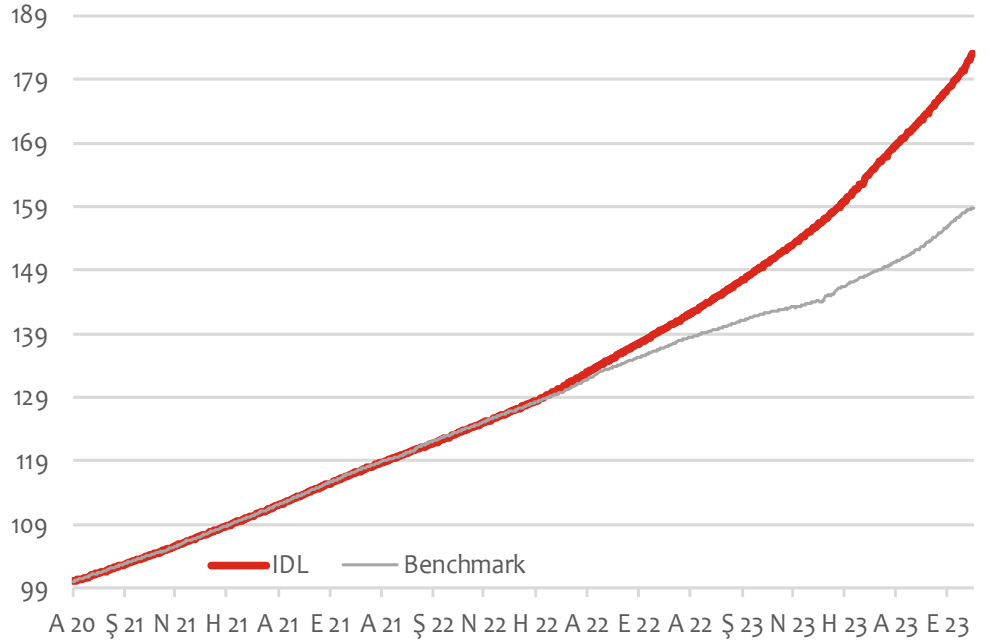
