The Fund primarily concentrates on USD Dollar instruments and aims to generate absolute, high and stable return under all market conditions, with a mid-to-long term investment perspective.

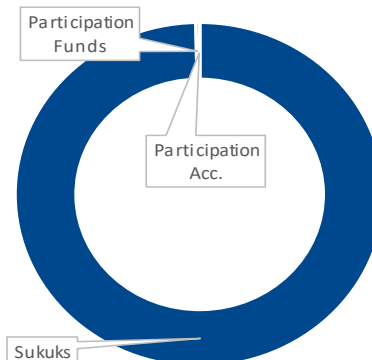

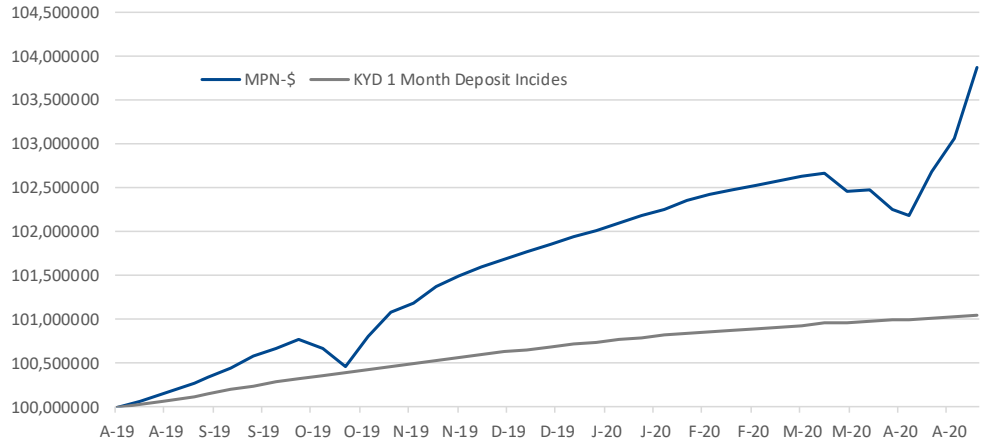
